Ultra Aluminum Fencing and Ultra Privacy products carry a Limited Lifetime Warranty against defects in workmanship and/or materials. The Powercoat™ finish on all Ultra fencing also carries a Limited Lifetime Warranty against cracking, peeling or chipping.

If the product should fail in accordance with any of the above conditions, the manufacturer, Ultra Aluminum, will offer replacement or renewal of the defective parts, providing the purchaser has registered the purchase within thirty (30) days of receipt of material. Notice of such a product failure must be sent to manufacturer in writing, together with a proof of purchase and photos showing the nature of the defect.

Please note: Ultra's Powercoat[™] finish offers you some of the best protection available against the elements, but a simple, regular cleaning is necessary to maintain the appearance.
